### Paper options

Each student will prepare a writing project. There are two options: a 20-25 page term paper or participation in a small-group research presentation. Students in the latter will prepare briefing papers on aspects of a human rights trial of former Iraqi dictator Saddam Hussein. These papers will be presented to a special session of the class held on December 6 in the Konover Auditorium, Dodd Center.
